- (a) Qualification: (i) Post Graduate Degree.  
(ii) Diploma/two years experience  
NOTE: Preference will be given to Post Graduate Degree holders.
- (b) Registration : Candidates must have/or have applied for registration in Delhi Medical Council.  
Selected candidates will have to produce DMC registration certificate at the time of joining.
- (c) Age Limit : Age as on the closing date i.e. 17.03.2010  
-General/UR - 35 years  
-OBC - 38 years  
-SC/ST - 40 years

(d) Tenure: SRs are appointed for maximum period of 3 years. However, initial appointment is made for 1 year extendable upto 03 years with annual extension on the basis of satisfactory work & conduct

NOTE: The candidates who have already worked in any of the Govt. Hospitals as Senior Resident, the period will be counted to calculate the period of Senior Residency. Those who have already worked for the period of 3 years in any of the government hospitals are not eligible.

(e) Candidates who have completed their internship before 31.03.08 are not eligible for applying for these posts.

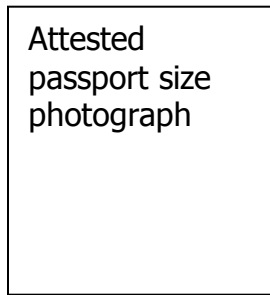

9. Tenure of the post of Junior Resident (MBBS) is maximum one year under residency scheme. However initial appointment will be made for a period of 06/six months which may be extended for further six months on the basis of satisfactory work & conduct report. It will be discretion of the appointing authority to posts the JRs in any of the departments of the hospital in case of exigency of work even between the period of six months.
10. The tenure of Junior Resident in Dentistry Department is for 06 months only in pursuance to order No. F.7/767/2007/H & FW/3795 dt. 08.10.2007 issued by the Addl. Secetary(H&FW) regarding tenure of Junior Resident in Dentistry.
11. The tenure of Senior Resident is for a period of 3 years including any service rendered as Senior Resident earlier on ad-hoc/regular basis in any recognized institution. The appointment will be initially for 01 year which can be extended further upto 3 years subject to satisfactory performance/work and conduct report. The other service conditions will be governed in accordance with the Residency scheme. The rules and instructions issued from time to time will also be applicable.

12. List of eligible candidates for interview will be displayed on Hospital's Notice Board opposite Establishment-I & on the hospital website.

\* No separate call letter for interview will be issued from the hospital. Therefore,

willing candidates should confirm their eligibility on website of the hospital or on the notice board.
